3. THE DEPOSIT WILL BE REFUNDED ONLY IF THERE IS NO DAMAGE, FACILITIES ARE CLEANED APPROPRIATELY, **ALL TRASH REMOVED** AND THE RESTROOMS ARE CLEANED AND IN GOOD ORDER. **USE DUMPSTER IN PLAYGROUND PARKING LOT!**
4. IF THE HOMEOWNER USES AUDIO, HE MUST KEEP IT LOW NOT TO MAKE A NUISANCE TO SURROUNDING PROPERTIES. IF SURROUNDING PROPERTIES COMPLAIN SECURITY WILL ASK HOMEOWNER TO TURN OFF AUDIO. MUSIC SHOULD END BY MIDNIGHT.

WITH THE SIGNING OF THIS AGREEMENT, THE HOMEOWNER AND THEIR GUESTS SHALL HOLD HARMLESS BELLEGRASS, LLC AND ALL OF THEIR MEMBERS, OFFICERS AND AGENTS FROM ANY LIABILITY OR CLAIM, REPRESENTATION OR COMPENSATION IF NECESSARY SHOULD ANY ACTION OR JUDGMENT RESULTING FROM ACTIVITIES OF HOMEOWNER.
